You helped people like "Hilda"

It was a huge blow to "Hilda" when her husband and child tested positive for COVID-19. Her child recovered well at home but her husband was taken to Los Angeles and put on a ventilator in the ICU. Nobody in the ICU spoke Spanish, and at one point Hilda hadn't gotten any updates for almost three weeks—an eternity when a loved one is fighting for his life. Every time the phone rang, Hilda would

be overcome with fear that the hospital was calling to say that her husband had died. Our bilingual staff facilitated a daily call between the nurses and Hilda so she could be kept up-to-date on her husband's condition. Her husband is now back home and recovering after his ordeal. Our staff recently assisted him with an unemployment application to support the family's financial health.

With Your Compassionate Support, Our Grief Counselors Helped Kids and Teens Through the **Pandemic**

"Working with teens on Zoom is a mixed bag. Most kids aren't as focused as they would be in person, and bad Internet connections can make communication difficult. On the other hand, I really get a sense of their home lives. One of my clients whose dad recently died walked me through the house on his phone, showing me photos of his dad and objects that were important to him. He also showed me the altar the family made to honor his dad. I think sharing the altar felt good to him since this family was not able to have a public memorial for his father due to the pandemic. This personal level of sharing has also deepened our therapeutic relationship." ~ Hospice of Santa Barbara Youth Bereavement Counselor

"The pandemic is making it so much harder to grieve. It's a whole layer on top of the grief people are already feeling. All the things we encourage people to do for social support – hobbies, seeing friends, going to church - they can't do that

> in the same way now. Sometimes Zoom meetings are the only contact with others that they have during the week.

devastating loss The isolation and the grief of the loss of our world makes dealing with a death not just a little harder, but ten times harder.

One reason is that people can't have in-person memorials right now. Having memorials over Zoom is just not the same since everyone has to stay distant, and can't hug each other, which is important for comfort. Clients who felt like they were barely keeping their heads above water before the pandemic feel like they are drowning now. Sessions have been very intense since the pandemic started."



Your IRA Can Help Support Your Values

Did you know you can become a Hospice of Santa Barbara Legacy Society member through your IRA?

There are two easy ways your IRA can be used to support the things that are important to you.

Name HSB as a beneficiary of your IRA

You can name a charity such as Hospice of Santa Barbara as a beneficiary to receive all or a portion of your IRA upon your death. In addition to supporting work you find valuable, there are some real tax benefits to this type of gift. For example, the donation can be used to offset estate taxes. Give part of your IRA's annual distribution to HSB

By taking a distribution from your IRA this year, you will likely pay more in taxes and may even reach a higher tax bracket. If you are 70½ or older you are eligible to make a charitable gift up to \$100,000 this year from your IRA to help further our mission.

This charitable distribution is applied to your "required minimum distribution" (RMD), and although you will not receive an income tax deduction, you will not pay taxes on IRA distributions made directly to us.
